### **Vic/Nominating Committee:** Starts the process of the election

**Peter Shearer**: Thanks to Vic the Commodore for keeping the place together

**D-Rod:** Motion to an exception to the bi-laws so we can do the voting without the 90 days waiting

**Vic:** You have to put that in writingand we'll deal with that at the next meeting, we want to make everything 30 days. According to the bi-laws you can't do it for this year, but it will be for next year.

**Clay**: Motion for safety reasons, membership to put combo lock on the club door for everyone.

**Vic**: We can talk about that, no problem with making that adjustment onto the building, general membership can have access to it. We'll put a combination lock.

Clay: 25 Watts of channel 16

**Vic**: Coast Guard is the way to go, we are not a rescue operation, unless we have something going on with a program, we can not offer 24-7 service. When you leave the beach, you're on your own. Tow Boat US offers a program, they will tow you.

**Clay**: Once the boat is flipped over and incapacitated, insurance doesn't cover it. If you have even a hull's upright with the mast up or not, or completely upside down, as long as it's not a hazard, they can put a line on it and they will tow you.

Vic: It's worth checking into that program

**Rich**: \$140 for Catamaran

**Tom Helstern**: If you don't have insurance and you call Sea Tow or Boat US, that is very expensive.
