Clay:The way we have it set up, 2 people runningas a team, what happens next year, 3 people running against 2? Could get out of control maybe, what we should do is follow our own bylaws that say that we need to have one person run against one person, then have bylaws say that the person who wins can assign an assistant
Vic: One full body
Vic: We can discuss that. And as we are talking about the election process, we have a bylawamendment, one of the bylaws. Nomination committee, was 90 days-down to 60 days, was 60 -now down to 30 to speed up the process.
We don't always have a body to fill the positions, we are a volunteer organization.
Accept bylaw change: $1^{\text {st }}$ Kathy, $2^{\text {nd }}$ Jim, needs to be2/3 membership, unanimous

## Vic/Bylaw amendment:

- Over the years sometimes we get issues about interaction between people in the club, physical or verbal.
- Want to make a motion that any complaint that comes into the club needs to be handled within 30 days of the incident.
- We had an incident last year and it belabored itself, occurred in May or June and we didn't hear about it until November. No reason for that.
- If you have a problem, we want to take care of it right away

Clay:Scenario of someone stealing, taking a long time to figure out who stole
Vic: Call the police

- Anything theft, physicalthe club shouldn't be involved, it's the job of the Police. No need to put people of the club in a bad situation

## Clay:

- We should follow a structure like "Robert's Rules"
- First complaint comes in and goes to the staff
- Better for everybody, vetted twice, that group, two groups
- $51 \%$ through the staff and then to the BOD, like a jury
- More people get to look at it, like our government, more fair
- Asking to remove from the bylaws, that what is written in there, how a complaint gets entered
- Replace it with use standard "Robert's Rules" procedure, what I described

Vic: Requires a bylaw change, looking to eliminate the bylaw, put something in writing to submit at next meeting
Larry: Can't vote now, has to go for discussion, vote on what you said, should be a motion
Clay: I'll print something up and make a motion for the next meeting, and a month from now we will have our first discussion
Vic: Create, lean back onto Roberts Rules
